Please be assured that all information provided is kept strictly confidential within the leadership of The Zion Company International.

## MINISTRY TRIP AWARENESS

### Ministry Teams

Everyone on the trip functions as one team. Occasionally, we may divide up into smaller groups to minister as it is needed. Additionally, each person will be a part of a smaller team of about 6-8 people, including a team leader, to have meals, pray and share testimonies together. These smaller teams are formed randomly by our ministries to encourage interaction by those who do not yet know one another.

### Ministry Conditions

Each team member must be able to meet the physical, emotional, and mental challenges with stamina that will be presented in various conditions while ministering. The pace required on these trips can be rigorous, emotionally draining, and physically exhausting. Flexibility is crucial to functioning as a team. We ask that you be prepared to be stretched beyond yourself and to go outside of your comfort zone. However, the harvest of souls and lives that will be impacted because of our “sacrifice” are of priceless value!

### Ministry Meetings & Outreach

Three areas in particular that we will be focusing on during this trip are: Mass Crusade Evangelism which leads to salvation and deliverance of the lost; mercy to the poor; and revival to the church. We will also hold meetings and conferences where there is a great focus on healing and outpouring of the Holy Spirit. You will be chosen for a team and will help in different areas of ministry as you are instructed.

## TERMS AND CONDITIONS

### What is covered?

The cost of the trip is ***all inclusive*** and includes your quality hotel room with breakfast, team meals (lunch & dinner), bottled water for your room, all in-country transportation (involving the ministry team), and security during crusade. The deposit reserves your spot on the trip based on completed application and acceptance. *We reserve the right to deny any application that does not fit the conditions we explain in this form.*

### What is NOT covered?

**You will be responsible to obtain your international flight to Sri Lanka and arrive upon the designated team day with no exceptions.** *Once your application is approved, more details will follow as to the schedule of events and how to book your flights accordingly with our travel agent. Keep in mind that you may leave a day or two prior to the “designated arrival date”*



depending upon the country you depart from. DO NOT BOOK ANY FLIGHTS UNTIL PAYMENTS HAS BEEN MADE IN FULL TOWARDS THE TRIP.

The cost of an E-Visa will be your responsibility. More details will be available once approved.

You will be responsible for your personal spending money, the cost of snacks, coffee, ice cream, etc. outside of mealtime, as needed, gratuities where appropriate, and immunizations/ Covid tests where required.

Also, please obtain some sort of traveler's or medical insurance while overseas. We will seek to assist you if medically necessary, however you will be responsible for any extra expenses incurred. Please note that we work diligently to obtain optimum prices. However, we would like to inform you that this price is subject to change depending on the exchange rate.

### **IMPORTANT PAYMENT INFO:**

- **A non-refundable deposit of \$150 USD is required along with the application.** If using PayPal, please consider the fees being taken out and sent via [PayPal.me/alexparkinson](https://www.paypal.com/alexparkinson). If you do not send this way, you will be charged the 4% fee and sent an invoice. As PayPal policy changes, we'll inform if your payment accrued the 4% fee or not. You may contact Jordan, for Zelle details (no fees, bank to bank) or advise her if you have mailed a check.
- The full trip payment is **USD \$2,000.00 per person** for double occupancy room (this amount already has your \$150 deposit included). Please note that single room occupancy will not be available. The first installment of \$1,000.00 is due no later than **February 15th, 2024**. The *final and full* payment of \$850 is due no later than **March 15th, 2024**. For **married couples**, it is **USD \$4,000.00** with the same due dates above. Please ensure that complete individual applications are submitted and include a note with the application that you're traveling with your spouse. No exceptions will be made. Please memo your payments: "Sri Lanka Team Payment".

### **QUESTIONS & ANSWERS**

**Q. Can I travel on my own and not use your travel agent?**

A. No, for Sri Lanka 2024, we will all be using our travel agent to make the travel arrangements to ensure arrival/departure are together as a team. More details to come after approval.



**Q. Can I have a single room on the trip?**

A. No, the pricing is based on a double occupancy room, and you are required to have a roommate. If there are an odd number of team members, we will give you the option to pay for your single room (price increases).

**Q. Can I leave for the trip early or stay later than the rest of the team?**

A. No. You must arrive/depart on the designated date. You may not extend your stay after the trip; you must arrive and depart with the team.

All further questions will be answered in your Welcome Email upon acceptance to the Sri Lanka 2024 Resurrection Power Miracle Crusade Team. An email and WhatsApp group will be created to communicate with the entire team for pertinent team details. ## **DISCIPLINE POLICY**

*“If your brother sins, go and show him his fault in private; if he listens to you, you have won your brother. But if he does not listen to you, take one or two more with you, so that **BY THE MOUTH OF TWO OR THREE WITNESSES EVERY FACT MAY BE CONFIRMED**. If he refuses to listen to them, tell it to the church; and if he refuses to listen even to the church, let him be to you as a Gentile and a tax collector.” –Matthew 18:15-17*

It is the intent of our ministry to follow the Biblical patterns of discipline within the confines of all international ministry trips. These ministry trips we do are attempting to open countries up to renewal and revival, often attracting spiritual warfare. *1 John 2:1- “My little children, I am writing these things to you so that you may not sin. And if anyone sins, we have an Advocate with the Father, Jesus Christ the righteous.”* Our goal is to create a safe, healthy environment, that then enables us to minister to the people of the country visited.

We recognize that ministry team members must be in a correct relationship with God and with others, thus ensuring completion of mission objectives. The consequences of one’s sin or disobedience have the potential to bring confusion and destruction to any ministry trip. We desire to come alongside each ministry team member in loving correction only when necessary. All compliance with any disciplinary action by our leadership team is greatly appreciated.

Below are procedures that will be followed by our leadership if any disciplinary action is necessary. To avoid any misunderstanding, please read the outlined procedures below, sign the consent form, and return it to our office. By consenting to the following, you agree to receive correction, public rebuke and/or removal, if decided necessary by our leadership. If issues of sin or disobedience come to light, rest assured, the steps below will be followed to bring resolution to the situation.

1. If you have a problem with any individual, you are to lovingly approach that person first, without going to any other ministry team member. Attempt to bring understanding and resolution to the conflict. If it is with someone of the opposite sex, please talk with him or her in a place where others are present but cannot hear your conversation. Many times, what you may consider a problem is simply a misunderstanding and bringing it to their attention often brings resolution.
2. If you find no resolution after you have conversed with the individual, the individuals involved are required to discuss the problem with a ministry team leader. The ministry team leader should be able to determine what the problem is, who is at fault, and bring closure to the situation.
3. If the ministry team leader discovers that there has been no closure to the situation, there will be another meeting with the parties involved, the ministry team leader, and the trip coordinator in order bring closure to the difficult situation.



4. If the ministry team leader and event coordinator find any individual to be in *rebellion to correction*, our representatives will be informed. The following representative will bring definite closure to the situation, in which all parties will be present to hear the conclusion of the matter in its finality. Possible conclusions may include an individual returning home within 24 hours or being brought before the whole ministry team for public correction. The ministry team will be informed not to have any personal contact with the individual throughout the remainder of the trip if it is absolutely necessary. The individual will not be permitted to eat, sleep, or travel with any ministry team member.
5. If any individual is involved in any sin that cannot, at the discretion of leadership, be taken care of in a timely manner or would affect the team in an adverse way, our leadership reserves the right to put procedure (4) into action immediately.
